Purpose of Data Processing and Legal Basis

Your personal data is collected for the registration of:

- Bulky waste (also at a desired date)
- Tree and shrub prunings for 4 or 5 households respectively, provision of containers included (7m³/10m³)

Your data is processed in accordance with the following legal basis:

Performance of a task that is in the public interest (Article 6 (1) e. DSGVO) in conjunction with § 1 Section 1, § 8 Section 2+6 and § 10 Section 5 of the Waste Management Statutes of the City of Magdeburg.

Source of the Personal Data

Personal data will be acquired in accordance with your request and the data processed in the course
of your order processing

Categories of Personal Data

The following personal data are processed:

- Address details
- Contact details such as phone number, email address
- Bulky waste: for the disposal of listed items
- Tree and shrub prunings: size of the container
- Date of disposal

Duration of Storage

The data collected during registration will be stored for a maximum of two calendar years. After this period, the data is deleted, or blocked should there be a legal obligation to retain them. The data will be deleted when the retention period expires.

The reason for the storage period of two calendar years is to check the permissible number of bulky waste disposals per calendar year according to the statutes as well as possible overlaps between registration and disposal dates at the turn of the year.

Is the provision of personal data required by law and necessary for the conclusion of the contract?

Without your consent to process your personal data, the order cannot be executed

Recipient of Your Personal Data

Administrative structures within the City of Magdeburg involved in the processing procedure
 Data will only be passed on to third parties within the framework of statutory regulations and legal obligations.
 In order to notify you of the disposal date, your address will be passed on to our dispatch service provider, who will be commissioned to deliver the postcard with the disposal date.

Data Protection Rights for Natural Persons

According to the GDPR, you have the following rights:

If your personal data is processed, you are entitled to obtain information about the data stored about you (Art. 15 GDPR). If incorrect personal data is processed, you are entitled to have them corrected (Art. 16 GDPR).

If the legal requirements are met, you may request the erasure or restriction of processing as well as object to processing (Art. 17, 18 and 21 DSGVO).

If you make use of your above-mentioned rights, the City of Magdeburg will check whether the legal requirements for this are met
